(the "Association") held on January 25, 2017, in accordance with the requirements of applicable Florida Statutes and the Association governing documents, the amendment set out below was duly adopted by an affirmative vote of (i) 75% of the Board of Directors, and (ii) the members who were entitled to cast 75% of all voting interests in the Association, present in person or by proxy. The Declaration of Covenants, Restrictions and Easements for Lancaster Neighborhood Association, Inc. (the "Declaration"), was recorded on April 21, 2000 in Official Record Book 10148, Page 1, as amended by that First Amendment to Declaration recorded on September 9, 2000 in Official Record Book 10360, Page 68, and as amended by that certain Supplemental Declaration recorded on March 3, 2001 in Official Record Book 10655, Page 65, all of the Public Records of Hillsborough County, Florida.

The following is added at the end of Section 12.25 of the Declaration:

No leasing of Homes will be allowed in the Neighborhood, unless the Owner has owned and lived in the Home for a period of at least one (1) year prior to submitting a lease application to the Association. For Homes that are owned by an entity, then an officer, director, member, partner, trustee or trust beneficiary, as applicable, must have lived in the Home for a period of at least one (1) year prior to submitting a lease application to the Association.
