The Declaration of Covenants, Restrictions and Easements for Ashington Neighborhood Association, Inc. (the "Declaration"), was recorded on February 11, 2000 in Official Record Book 10047, Page 1115, as amended by that Corrective Amendment recorded on April 19, 2000 in Official Record Book 10144, Page 1889, all of the Public Records of Hillsborough County, Florida.

The following is added at the end of Section 12.25 of the Declaration:

No leasing of Homes will be allowed in the Neighborhood, unless the Owner has owned and lived in the Home for a period of at least one (1) year prior to submitting a lease application to the Association. For Homes that are owned by an entity, then an officer, director, member, partner, trustee or trust beneficiary, as applicable, must have lived in the Home for a period of at least one (1) year prior to submitting a lease application to the Association.
